^{3 (}three) posts reserved for Persons with Benchmark Disabilities in the non surgical departments as per Government of India policy:

Criteria for Persons with Benchmark Disabilities: One per cent each reserved for persons with benchmark disabilities under clauses (a), (b) and (c) and one per cent for persons with benchmark disabilities under clauses (d) and (e) namely:-

- (a) Blindness and low vision;
- (b) Deaf and hard of hearing;
- (c) Locomotor disability including cerebral palsy, leprosy cured, dwarfism, acid attack victims and muscular dystrophy;
- (d) Autism, intellectual disability, specific learning disability and mental illness;
- (e) Multiple disabilities from amongst persons under clauses (a) to (d) including deaf-blindness in the posts indentified for each disabilities.

The disability certificate should be issued by a duly constituted ad authorized Medical Board of the State or Central Government Hospital/Institutions and countersigned by Medical Superintendent/CMO/Head of Hospital/Institution.

The Medical Board issuing certificate shall conform to guidelines of Ministry of Social Welfare and Empowerment (Govt.of India)

Candidates from General Category will also be considered for adhoc appointment against vacant post of reserved category (<u>marked asterisk</u>*), if reserved category candidates would not be available.

The numbers of vacant posts indicated above are inclusive of backlog vacancies.

As per guidelines EWS posts are not carried forward/or considered as backlog vacancy in case unfilled hence other category candidates may be allowed provisionally to apply for the post subject to the condition that they will be considered for the post as UR candidate only if EWS category seat is otherwise not filled up. (Not applicable for the EWS post of SRD department of General Surgery as this is a fresh vacancy)

A. Essential Qualification for the post of Senior Resident Doctors:

- i. Postgraduate degree or diploma in respective subject recognized by MCI after obtaining a medical qualification included in the Schedule I & II of the 3rd Schedule of Indian Medical Council Act 1956 (persons possessing qualifications included in the part II of the 3rd schedule should also fulfill the conditions specified in section 13 (B) of the Act).
- ii. Satisfactory completion of the compulsory internship/housemanship in a recognized hospital.
- iii. Candidate must be registered with the State Medical Council/Medical Council of India.
- B. Desirable: Candidates having experience in the respective discipline/subject will be preferred.

Scale of Pay: Level 11 of Pay Matrix with entry pay of ₹.67700/- per month plus NPA and other allowances as admissible under the Central Govt. Rules in identical posts.

Age limit - 45 years

Eligible candidates who wish to appear for in-person interview are requested to present themselves for registration at 09:30 a.m to 10:45 a.m on 23rd & 24th March 2022 in the Conference Hall, NEIGRIHMS Guest House, Permanent Campus, Mawdiangdiang.

Candidates who are not able to appear for the Walk-in interview in person on 23rd & 24th March 2022, can submit their applications in prescribed proforma (Annexure - I) alongwith self attested scanned copies of their certificates by email to neigrihms.recruitment@gmail.com upto 18th March 2022 (Friday) till 5:30 PM. The interview of Eligible candidates via Video Conference will be conducted on 25th & 26th March 2022.

- 1. Reservation for the above posts and age relaxation will be provided as per Govt. of India Norms. Age is relaxable upto 5 (five) years for SC/ST and 3(three) years for OBC (Noncreamy layers) candidates in respect of vacancies reserved for them. Age relaxation for physically handicapped candidates will be provided as per Govt. of India Norms.
- Reservation for Economically Weaker Sections (EWSs) shall be applicable as per Govt.of India policy Office Memorandum No.36039/1/2019-Estt (Res) dated 19th January, 2019 and 31st January, 2019.
 - EWSs Candidates will attach certificate issued by the competent authority in the form prescribed as per Annexure-II.
- 3. If employed under the State or Central Govt. or PSU/Autonomous body, applicants are required to produce NOC from competent authority, failing which they will not be allowed to appear for interview under any circumstances.
- 4. Candidate who have already worked in State or Central Govt. or PSU/Autonomous body and have resigned/left their jobs are required to produce the Relieving Order, failing which they will not be allowed to appear for interview under any circumstances.
- 5. Canvassing in any form will disqualify candidate.
- 6. Crucial date for determination of eligibility with regard to age, educational qualification and experience etc. will be the date; the candidates appear in the interview.
- 7. For the post of Senior Resident Doctor, Candidates holding DNB qualifications would need to get their qualification verified by NBE as to whether it is as per the requirement of the

Gazette notification No.MCI-12(2)/2010-Med.Misc dated 11.6.2012 and produce such verification certificate at the time of interview.

- 8. Candidates who does not fulfill any one of the above conditions, will not be allowed to appear in the interview. They are to ensure that they fulfill the eligibility criteria before coming to appear the walk in interview.
- Candidates who have been sponsored by the Govt. of Meghalaya for MBBS/MD/MS
 programme are required to produce NOC from the Govt. of Meghalaya, failing which they
 will not be allowed to appear for interviews under any circumstances.
- 10. Candidates who have been sponsored by the respective state governments for pursuing MBBS course and are required to undergo compulsory rural posting, if any. Such candidates will have to submit the certificate of completion of rural posting.
- 11. Appropriate accommodation as per availability will be provided.
- 12. No travelling allowance will be paid by this office for attending the interview.
- 13. Institute reserves the right to reject or accept any candidature without assigning any reason thereof.
- 14. The decision of the Institute as to eligibility or otherwise of a candidate will be final.
